Dear Ms. Dortch:

The purpose of this letter is to inform, on behalf of WorldNet Telecommunications Inc. (“WorldNet”) and pursuant to 47 CFR § 63.24(f), that WorldNet Telecommunications Inc. changed its corporate form and is now WorldNet Communications, LLC (“WorldNet”), and that in connection with that change WorldNet’s owners made pro forma changes to their ownership of WorldNet. These *pro forma* transfers of control were executed in connection with the January 4, 2021, consummation of the transaction between WorldNet and Liberty Communications of Puerto Rico LLC, approved in WC Docket No. 20-351.<sup>1</sup>

The information required pursuant to 47 CFR § 63.24(f)(2)(i) follows, and the certification required pursuant to 47 CFR § 63.24(f)(2)(ii) is attached.


