Dear Ms. Dortch:

Pursuant to Sections 63.24(d) and (f) of the Rules of the Federal Communications Commission (“FCC” or the “Commission”), 47 C.F.R. §§ 63.24(d) and (f), Chesnee Long Distance, Inc. (“Chesnee LD”) hereby notifies the Commission of the consummation of the *pro forma* transfer of control of the international Section 214 authority held by Chesnee LD to Chesnee Cable, Inc. (“Chesnee Cable”), both d/b/a Chesnee Communications.

This assignment took place as a result of a larger corporate restructuring Chesnee LD will merge into Chesnee Cable, with Chesnee Cable being the surviving entity. Both Chesnee LD and Chesnee Cable are wholly owned subsidiaries of Chesnee Telephone Company, Incorporated, d/b/a Chesnee Communications (“Chesnee Tel”). Chesnee Tel is a wholly owned subsidiary of SkyLine Telephone Membership Corporation (“SkyLine”). Chesnee LD and Chesnee Cable share common management, employees and office facilities. As the surviving entity, Chesnee Cable will automatically assume the assets and liabilities of Chesnee LD.

A statement regarding previously received authority under Section 214 and a general description of the facilities and services authorized:

Chesnee Cable holds blanket domestic Section 214 authority to provide domestic telecommunications services. Chesnee LD has existing international Section 214 authority under File No. ITC-214-19990903-00581 to provide resold global or limited global telecommunications services and implicit Section 214 authority to provide domestic resold toll telecommunications services.

(e) 47 C.F.R. § 63.18(h) – ANSWER TO QUESTION 11:

The name, address, citizenship and principal place of business of any person or entity that directly or indirectly owns at least ten percent of the equity of the applicant, and the percentage of equity owned by each of those entities (to the nearest one percent). 
Neither Chesnee LD nor Chesnee Cable is a foreign carrier, and neither is affiliated with a foreign carrier.
