
Dear Ms. Dortch:

Nedelco, Incorporated ("Nedelco") files this supplement regarding its ownership of Hamilton Telephone Company ("HTC"). Based upon a review of the Public Notice issued on September 10, 2021 in WC Docket No. 21-344 (DA 21-1139), an inadvertent error has been identified in the information set forth in the Application regarding Nedelco's stock ownership percentage of HTC. Nedelco hereby clarifies and corrects the fact that rather than being 100% owned by Nedelco as stated on page 9 of the Application, Nedelco owns 98.4% of HTC. No new 10% or greater ownership in Nedelco is triggered by this correction. Nedelco regrets this inadvertent error.


