Answers to Questions 10 and 11

The ultimate and continuing controlling shareholders of Whidbey Telephone Company (“WTC”) -- the 2012 George T. F. Henny Trust, the 2012 Julia Henny DeMartini Trust and the 2012 Mark P. Henny Trust -- hereby notify the Commission of a *pro forma* transfer of control that took place on December 31, 2021 and that involved WTC and its wholly-owned subsidiary Western Long Distance, Inc. (“Western”) and the International Section 214 authorization for global resale of switched services held by Western (File No. ITC-214-20000315-00172). The specific change was the insertion of a new entity – Abound Ventures, Inc. (“AVI”) – between the ultimate controlling shareholders and WTC. The 2012 George T. F. Henny Trust, the 2012 Julia Henny DeMartini Trust and the 2012 Mark P. Henny Trust will continue to control the same percentages of the stock of AVI, the new parent company, as they controlled the stock of WTC prior to the said *pro forma* transfer of control.

No other individual or entity directly or indirectly owns or controls a ten (10) percent or greater equity or voting interest in AVI, WTC or Western after completion of the subject *pro forma* transfer of control.
