RE: Long Lines Communications and Long Lines, LLC Notification of *Pro Forma* Transaction

Dear Ms. Dortch:

Long Lines Communications and Long Lines, LLC (jointly, “the Parties”), by counsel, submit this Notification of Pro Forma Transfer, pursuant to Section 63.24(d) of the Commission’s rules, 47 C.F.R. 63.24(d).

Long Lines, LLC holds blanket domestic 214 authority and international 214 authority File No. ITC-214-20060724-00362 and provides telecommunications services to customers in Iowa. Long Lines Communications is a Delaware limited liability company organized as a holding company for ILECs, CLECs and cable providers offering broadband, video and voice services in sixteen communities in Iowa, Nebraska, and South Dakota. As a holding company, Long Lines Communications does not hold international or domestic 214 authority.

By this *pro forma* notice filing the Parties provide the Commission notice of a 2006 corporate reorganization by which Long Lines Communications was formed and inserted in the ownership structure as the direct parent of Long Lines, LLC. At that time, each of the equity interest holders in Long Lines, LLC exchanged their interests for an equal ownership in Long Lines Communications, LLC, which thereby became the 100 percent owner of Long Lines, LLC. From the period between 2006 until 2015, Long Lines Communications was the direct parent of Long Lines, LLC.

The parent-subsidary relationship between the two companies is reflected in Exhibit A of the domestic 214 transfer of control application filed by Schurz and Schaller on June 30, 2022, in WC Docket 22-249. The Wireline Competition Bureau consented to that application on November 28, 2022.¹ In 2015, Schurz acquired Long Lines, LLC from Long Lines Communications. Pursuant to a Membership Interest Purchase Agreement dated as of January 15, 2015, Schurz Communications, Inc. agreed to purchase 100% of the equity ownership

interests of Long Lines, LLC from Long Lines Communications. The transaction closed in 2015.² Subsequent to the close of the transaction Long Lines Communications proceeded to wind down its operations and subsequently dissolved in 2016.
