RE: Schurz Communications, Inc. Notification of *Pro Forma* Transaction

Dear Ms. Dortch:

Schurz Communications, Inc. ("Schurz"), by counsel, submit this Notification of Pro Forma Transfer, pursuant to Section 63.24(d) of the Commission's rules, 47 C.F.R. 63.24(d).

Schurz is an Indiana Corporation organized as a holding company for ILECs, CLECs and cable providers offering broadband, video and voice services in numerous communities across a number of states. As a holding company, Schurz does not hold international or domestic 214 authority, although several of its affiliates do hold such authorizations.

By this *pro forma* notice filing the Parties provide the Commission notice of a legal structure reorganization whereby Schurz transferred its ownership of Long Lines, LLC down to IH Orbitel, Inc., a wholly-owned subsidiary of Schurz. IH Orbitel became part of the corporate family of Schurz Communications, Inc. ("Schurz") and entered the ownership chain when Schurz purchased Orbitel Communications, LLC, on July 1, 2012. Orbitel Communications, LLC does not currently hold any 214 authorizations, nor did it hold any 214 authorizations in 2012 at the time Schurz acquired the company.¹ In December 2017, Schurz executed a legal structure reorganization where Schurz transferred its ownership of Long Lines, LLC down to IH Orbitel, Inc. ("IH Orbitel"), a wholly-owned subsidiary of Schurz Communications, Inc.

¹ The company is not associated with other entities that may share portions of the same name. For example, Orbitel, Ltd. and Orbitel S.A. E.S.P., each of which appear to hold some FCC authorizations, have no relation to Orbitel Communications, now known as IH Orbitel.
