Notification of *Pro Forma* Transfer of Control of International Section 214 Authorization

Pursuant to Section 214 of the Communications Act of 1934, as amended, and Section 63.24(f) of the Commission's rules,¹ the Commission is hereby notified of an internal reorganization that resulted in the *pro forma* transfer of control of Hancock Long Distance, Inc. ("Hancock") and its international Section 214 authorization. The internal reorganization, which occurred on July 1, 2026, did not result in a change in the ultimate control of Hancock or its international Section 214 authorization.

Additional information responsive to FCC Form 214-TC regarding the *pro forma* transfer of control of Hancock is set forth below.

Response to Items 16, 24, and 28

An internal reorganization was undertaken on July 1, 2026, that resulted in the *pro forma* transfer of control of Hancock and its international Section 214 authorization. Specifically, a new intermediate holding company (Archtop Fiber Parent LLC) was inserted into the Hancock ownership chain.

Exhibit A includes charts depicting Hancock's ownership prior to and after the internal reorganization. As Hancock remains under the control of Post Road Group, a private equity investment firm, the internal restructuring was *pro forma* in nature.⁵ Moreover, together with all previous *pro forma* transactions, the internal reorganization does not result in a change in Hancock's ultimate control. The internal reorganization also is in the public interest as it facilitates continued support and investment in Hancock and its provision of services, and it will not result in any public interest harms.⁶

Response to Item 18

The internal reorganization described herein is *pro forma*, and thus is excluded from referral to the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector pursuant to Section 1.40001(a)(2)(i) of the Commission's rules.⁷

PRE-CONSUMMATION OWNERSHIP CHART

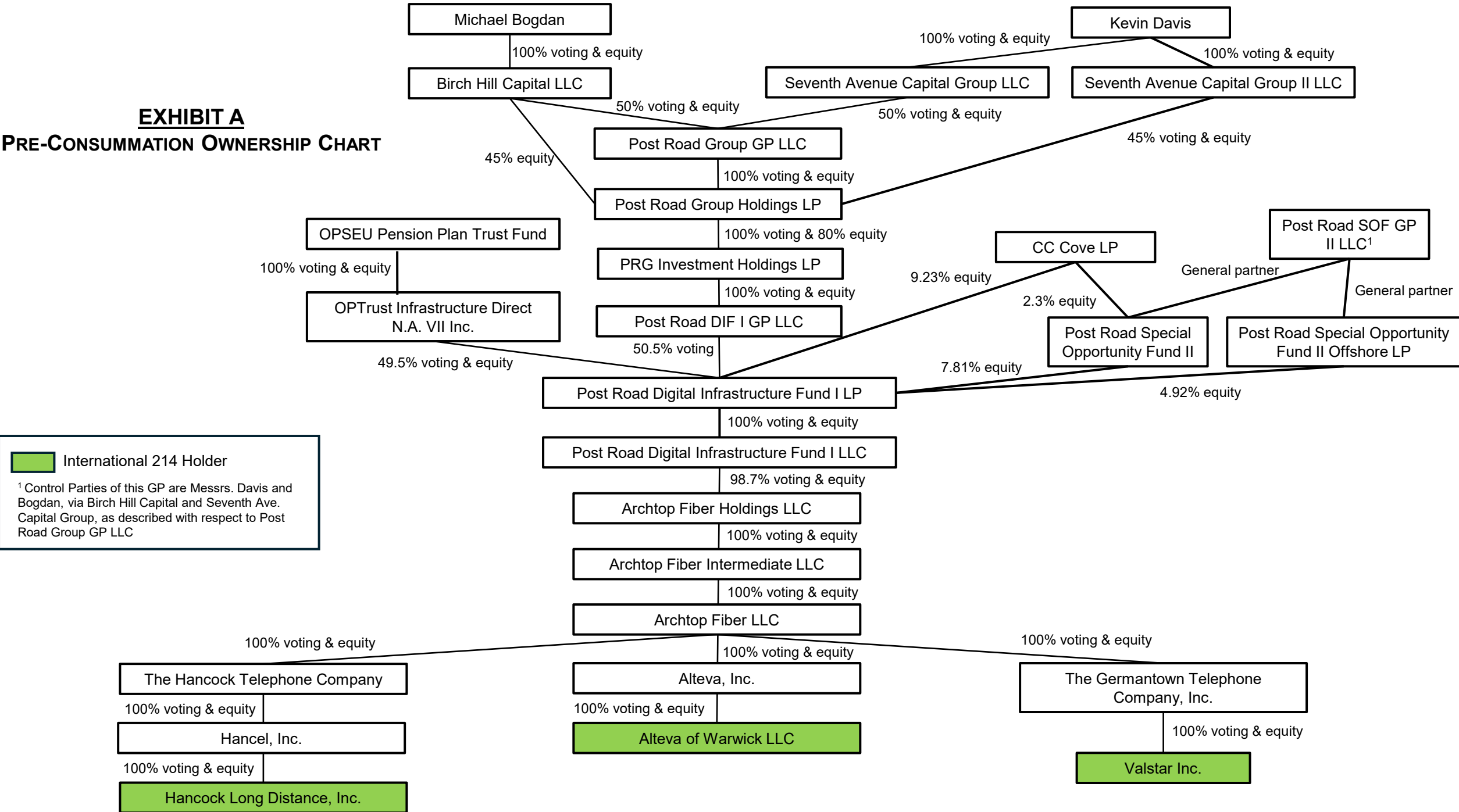
