### Notification of the Pro Forma Transfer of Control of Frontier Southwest Inc.

Pursuant to Section 64.24(f) of the Commission's rules,<sup>1</sup> the Commission is hereby notified of the internal restructuring and *pro forma* transfer of control of Frontier Southwest Inc. ("Frontier Southwest"),<sup>2</sup> which holds an international Section 214 authorization. Because the restructuring did not result in a change in the ultimate control of Frontier Southwest, which remains with Frontier Communications Corporation ("Frontier"), the transfer was *pro forma* in nature.

**Answer to Question 13**

On June 22, 2018, Frontier undertook an internal corporate restructuring in which Frontier Southwest changed from an indirect wholly-owned subsidiary of Frontier to a direct wholly-owned subsidiary of Frontier. Specifically, prior to the restructuring, Frontier Southwest was a direct wholly-owned subsidiary of Newco West Holdings LLC (“Newco West”), which in turn is a direct wholly-owned subsidiary of Frontier. As a consequence of the restructuring, Newco West is no longer an intermediate holding company between Frontier and Frontier Southwest, and Frontier Southwest is now a direct wholly-owned subsidiary of Frontier. Because the restructuring did not change the ultimate ownership or control of Frontier Southwest, which remains with Frontier, the transfer of control was *pro forma* in nature.
