Answers to Questions 10, 11, 12, 13, 14, 15, 16, 17, 18 and 20

The Estate of Patrick L. Eudy (Jane R. Eudy, Executrix and Personal Representative) is being distributed and the 68.63 percent member interest held by the Estate in Dialog Telecom LLC (“Dialog”) is proposed to be transferred to the Patrick L. Eudy Irrevocable Trust (Jane R. Eudy, Trustee). This proposed distribution will transfer control of the International Section 214 Authorization for global resale of AMA Communications, LLC (ITC-214-19980622-00430), a wholly-owned subsidiary of Dialog, from the Estate of Patrick L. Eudy (“Eudy Estate”) to the Patrick L. Eudy Irrevocable Trust (“Eudy Trust”).

Patrick L. Eudy, who owned a 68.63 percent member interest in Dialog, was killed in the crash of his private airplane on June 20, 2013. On August 2, 2013, a notice of the *pro forma* transfer of control of the International Section 214 Authorization for Global Resale of AMA Communications, LLC (“AMA”) was filed in the International Bureau Filing System (“IBFS”).

Jane R. Eudy, a U.S. citizen, is the sole Trustee of the Eudy Trust.

The beneficiaries of the Eudy Trust are Jane R. Eudy and the four children of Patrick L. Eudy (deceased) and Jane R. Eudy. All are United States citizens and all can be reached at 5550 77 Center Drive, Suite 220, in Charlotte, NC 28217.

No other entity owns or will own ten percent (10.0%) or more of the member interests of Dialog or its wholly-owned subsidiary AMA either prior or subsequent to the proposed transfer of control.

Answer to Question 12

The proposed transaction entails the distribution of the controlling 68.63 percent majority member interest in Dialog, and includes control of Dialog's wholly-owned subsidiary AMA, the holder of the subject International Section 214 Authorization for Global Resale.

Answer to Questions 14, 15, 16, 17 and 18

Neither Dialog nor AMA: (a) is a foreign carrier; (b) controls, is controlled by, or is under common control with a foreign carrier; (c) is affiliated with a foreign carrier; nor (d) will be affiliated with a foreign carrier upon consummation of the proposed transfer of control.

Answer to Question 20

The Applicants qualify for streamlined processing pursuant to Section 63.12 of the Commission's Rules because: (a) neither the Eudy Estate nor the Eudy Trust nor Dialog nor AMA is affiliated with any foreign carrier in any destination market; (b) neither the Eudy Estate nor the Eudy Trust nor Dialog nor AMA is affiliated with any dominant U.S. carrier whose international switched or private line services AMA seeks authority to resell; (c) neither the Eudy Estate nor the Eudy Trust nor Dialog nor AMA seeks authority to provide switched basic services over private lines to any country (much less, to any country for which the Commission has not previously authorized the provision of switched services over private lines); and (d) neither the Eudy Estate nor the Eudy Trust nor Dialog nor AMA has any reason to believe that the Commission will inform it in writing that this application is not eligible for streamlined processing.
