**Notification of *Pro Forma* Transfer of Control**

Pursuant to Section 214 of the Communications Act of 1934, as amended, (“the Act”), 47 U.S.C. § 214 and Section 63.24(f) of the Commission’s rules, 47 C.F.R. § 63.24(f), Cumberland Cellular, Inc. (“Transferor”) and Cumberland Cellular, Inc. (“Transferee”) hereby provide notification of the *pro forma* transfer of control of the international Section 214 authorization held by Cumberland Cellular Partnership. As more fully explained in response to Question 13 below, the ultimate ownership or control of the international Section 214 authorization at issue has not changed, and is, therefore, *pro forma* in nature. The *pro forma* assignment of the international Section 214 authorization occurred on December 31, 2019.

### **ANSWER TO QUESTION 13**

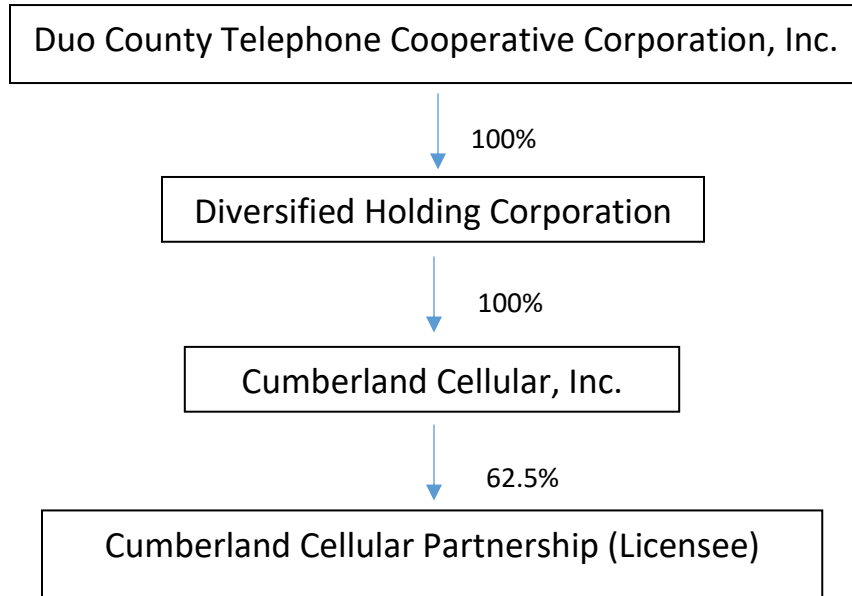
The transfer of control of the international Section 214 authorization held by Cumberland Cellular Partnership from Transferor to Transferee is *pro forma* in nature.

Prior to consummation of the subject transaction, Transferor directly owned a 62.5% general partnership interest in Cumberland Cellular Partnership. Transferor was a wholly owned subsidiary of Diversified Holding Corporation, which was a wholly owned subsidiary of Duo County Telephone Cooperative Corporation, Inc., a cooperative corporation owned by its subscriber members in which no subscriber owns as much as a one percent interest. On December 31, 2019, Diversified Holding Corporation was merged into Transferor with Transferor being the surviving entity. Subsequently, Transferor was converted to a limited liability company, Cumberland Cellular, LLC (Transferee).

Therefore, the international Section 214 authorization continues to remain under the same control both prior to and following consummation of the transaction.
