## Answer to Question 10

This notification is being submitted following conversion of Newcastle Holdings, Inc. to a limited liability company and a *pro forma* reorganization of its parent companies.<sup>1</sup> Newcastle Holdings, LLC ("Newcastle") is a North Carolina limited liability company whose address is 60 Beckwith Drive, Colorado City, CO 81019. Newcastle is a wholly owned subsidiary of USConnect Acquisitions IV, LLC, which is in turn a wholly owned subsidiary of USConnect Holdings, LLC ("USConnect"). Newcastle holds a Section 214 international global resale authorization which is used by Newcastle's wholly owned subsidiary DTI to provide international telecommunications services.<sup>2</sup> Newcastle functions as a holding company and does not itself provide any services. The authorization held by Newcastle is limited to the international 214 authorization under which DTI provides international long-distance service. Newcastle was among the USConnect subsidiaries included in the application for transfer of control filed in In the Matter of Joint Application of USConnect Holdings, Inc. et al, WC Docket No. 21-229, ITC-T/C-20210521-00087 (the "Application"). Newcastle's ultimate parent company, ITC Broadband Holdings, LLC ("ITC Holdings"), is a Delaware limited liability company located at 1791 O.G. Skinner Drive Suite A, West Point, GA 31833. ITC Holdings provides domestic and international telecommunications services through its subsidiaries but does not itself hold any Commission authorizations.

Pursuant to the Commission's rules, the Application was granted as of July 31, 2021. The parties consummated the transaction on August 16, 2021. At that time, direct control of

USConnect was transferred to ITC Rural Connect, Inc. ("ITC Rural"), a wholly owned subsidiary of ITC Holdings. As a result, ITC Holdings held ultimate indirect control of Newcastle and other subsidiary licensees (collectively, the "Licensees"<sup>3</sup>).

Subsequent to the August closing and as explained at pages 10-11 of the Application, certain subsidiaries of ITC Holdings were reorganized. First, ITC Rural converted USConnect and all of its subsidiaries that were corporations, including Newcastle, to limited liability companies under relevant state laws.<sup>4</sup> A chart listing the original USConnect subsidiaries and their post-reorganization names and entity types has been provided as part of Attachment 2 to this notification.

Following those conversions, on August 30, 2021, ITC Rural contributed the equity interests of USConnect to ITC Broadband Operating, LLC ("ITC Operating") as a capital contribution in exchange for 100% of the preferred membership interests of ITC Operating. ITC Fiber Holdings, LLC also contributed certain assets and capital to ITC Operating in exchange for the common membership interests in ITC Operating. The ultimate result of the two-step reorganization is that ITC Holdings, through ITC Operating and ITC Rural, still indirectly owns 100% of the equity interests of, and thus controls, USConnect, which in turn still owns 100% of the equity interests of each of the Licensees, including Newcastle.
