In addition to this application, MSV on this date has also filed two additional identical applications for (i) minor modification of its space station license for the L-band satellite AMSC-1 to add authority to operate an ATC and (ii) minor modification of a mobile earth terminal license it holds authorizing access to the L-band satellite MSAT-1, licensed by Industry Canada, to add authority to operate an ATC in conjunction with MSAT-1 and its replacement. MSV requests consolidated treatment of these three applications.
