**43. Description. (Summarize the nature of the application and the services to be provided).**

This amendment provides additional information concerning the V-band characteristics of NGST's NGSO proposal in response to the Commission's January 29, 2004 Public Notice inviting conforming amendments (Report No. SPB-199). In addition, the amendment changes the orbital architecture of the proposed system to include three planes of NGSO satellites operating in highly-elliptical orbits ('HEO') as well as a plane of four geosynchronous satellites. All seven (7) satellites will operate in the Ka-band primary NGSO spectrum and in the 2 x 3000 MHz of V-band spectrum. The HEO satellites will also operate on a secondary, non-unacceptable interference basis in the 19.7-20.2 GHz and 29.5-30.0 GHz bands. Full details are provided in the attached Technical Appendix.
