On September 15, 2004, the International Bureau (IB) reinstated the application filed on February 9, 2004 by Mobile Satellite Ventures Subsidiary LLC (MSV) seeking to add 50 MHz of Planned Ku-band spectrum to its pending application for a replacement Mobile Satellite Service (MSS) satellite at 101W. See Order, DA 04-2985 (September 15, 2004). In its decision, the IB required MSV by September 28, 2004 to supplement this application with (i) a two-degree spacing analysis and (ii) further information pertaining to its request to operate the proposed satellite with an East-West station keeping tolerance of +/- 0.1 degree. Id. paras.12, 14. MSV provides this information in the attached Technical Appendix. Complete technical information regarding the proposed replacement satellite is contained in the February 9, 2004 amendment that was reinstated by the IB. See File No. SAT-AMD-20040209-00014.
