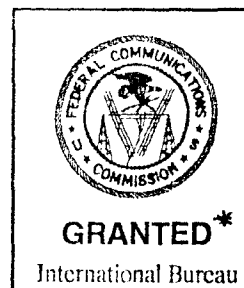

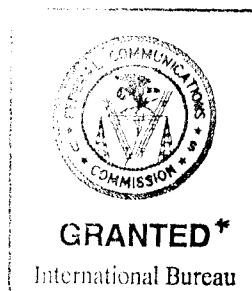

The DIRECTV Enterprises, LLC ("DIRECTV") modification request, SAT-MOD-20060908-00101, as amended by SAT-AMD-20060918-00102, IS GRANTED. Accordingly, DIRECTV IS AUTHORIZED to operate the DIRECTV 9S satellite's on-station telecommand functions on the 17795 MHz (uplink) frequency. This authorization is granted in accordance with the terms, conditions, and technical specifications set forth in DIRECTV's application, the Commission's rules, and the conditions below:

1. DIRECTV shall coordinate its telecommand operations with all potentially affected lawfully operating satellite networks to ensure that no unacceptable interference results from its telecommand operations on 17795 MHz.
2. The terms and conditions of DIRECTV's previous authorizations for the DIRECTV 9S satellite¹ other than the on-station telecommand frequency are not modified by this grant.
3. DIRECTV is afforded thirty days from the date of release of this authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
4. This Authority is granted pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately.
