The application of XM Radio Inc. (XM Radio) to modify its authorization to operate the Satellite Digital Audio Radio Service (SDARS) satellite, XM-3 (Call Sign S2617), and to co-locate the satellite with the XM-1 (Call Sign S2118) and the XM-2 (Call Sign S2119) satellites at the 85° W.L. orbital location IS GRANTED. Accordingly, XM Radio is authorized to operate XM-3 at the 85.083° W.L. orbital location, subject to the Commission's rules, the terms of its authorization, as amended, the technical specifications set forth in its applications, and the conditions set forth below.

1. XM Radio is authorized to operate XM-3 at the 85.083° W.L. orbital location with an East-West station-keeping tolerance of ± 0.05 degrees, pursuant to Section 25.210(j) of the Commission's rules, 47 C.F.R. § 25.210(j). XM Radio is permitted to operate XM-3 with a smaller station-keeping tolerance of ± 0.033 degrees in order to facilitate the safe-flight profile of its satellites.
2. XM Radio has 30 days from the date of this grant to decline this authorization as conditioned.
3. This grant is issued pursuant to 47 C.F.R. § 0.261, the Commission's rules on delegated authority, and is effective upon release.
