XM Radio Inc. Application for Modification

IBFS File Nos. SAT-MOD-20070912-00124, SAT-AMD-20071113-00157, SAT-AMD-20080129-00031 (XM-1, Call Sign S2118)

The application of XM Radio Inc (XM Radio) to modify its authorization to operate the Satellite Digital Audio Radio Service (SDARS) satellite, XM-1 (Call Sign S2118), and to co-locate the satellite with the XM-2 (Call Sign S2119) and the XM-3 (Call Sign S2617) satellites at the 85° W.L. orbital location IS GRANTED. Accordingly, XM Radio is authorized to operate the XM-1 satellite as an in-orbit spare at the 85.150° W.L. orbital location, subject to the Commission's rules, the terms of its authorization, as amended, the technical specifications set forth in its applications, and the conditions set forth below.

- 1. XM Radio is authorized to operate the XM-1 satellite at the 85.150° W.L. orbital location as a non-transmitting (except for telemetry transmissions in the 2332.5-2345 MHz frequency band) in-orbit spare for the duration of the license term of the XM-1 satellite. Pursuant to its initial authorization, the license term for the XM-1 satellite expires on May 31, 2009.
- 2. XM Radio is authorized to operate XM-1 at the 85.150° W.L. orbital location with an East-West station-keeping tolerance of ± 0.05 degrees, pursuant to Section 25.210(j) of the Commission's rules, 47 C.F.R. § 25.210(j). XM Radio is permitted to operate XM-1 with a smaller station-keeping tolerance of ± 0.033 degrees in order to facilitate the safe-flight profile of its satellites.
- 3. XM Radio may activate the communications payloads of XM-1 in the 2332.5-2345 MHz frequency band in the event of a service outage of the XM-3 (Call Sign S2617) or XM-4 (Call Sign S2616) satellites.
- 4. In the event XM Radio activates the communications payloads of the XM-1 satellite pursuant to condition 3 above, XM Radio must notify the Commission, in writing, of such activation within three business days of the start of the activation.
- 5. XM Radio must operate the XM-1 satellite in compliance with international coordination agreements with Canada and Mexico that limit the power flux density level from U.S.-licensed DARS satellites into Canada and Mexico.
- 6. XM Radio has 30 days from the date of this grant to decline this authorization as conditioned.
