

### XM Radio Inc. Application for Modification

The application of XM Radio Inc. (XM Radio) to modify its authorization to operate the Satellite Digital Audio Radio Service (SDARS) satellite, XM-3 (Call Sign S2617), and to co-locate the satellite with the XM-1 (Call Sign S2118) and the XM-2 (Call Sign S2119) satellites at the 85° W.L. orbital location IS GRANTED. Accordingly, XM Radio is authorized to operate XM-3 at the 85.083° W.L. orbital location, subject to the Commission's rules, the terms of its authorization, as amended, the technical specifications set forth in its applications, and the conditions set forth below.

- 1. XM Radio is authorized to operate XM-3 at the 85.083° W.L. orbital location with an East-West station-keeping tolerance of  $\pm 0.05$  degrees, pursuant to Section 25.210(j) of the Commission's rules, 47 C.F.R. § 25.210(j). XM Radio is permitted to operate XM-3 with a smaller station-keeping tolerance of  $\pm 0.033$  degrees in order to facilitate the safe-flight profile of its satellites.
- 2. XM Radio has 30 days from the date of this grant to decline this authorization as conditioned.
- 3. This grant is issued pursuant to 47 C.F.R. § 0.261, the Commission's rules on delegated authority, and is effective upon release.
