The application filed by PanAmSat Licensee Corp. (PanAmSat), as amended, to extend the license term for its C- and Ku-band Fixed Satellite Service (FSS) space station, Intelsat 2 (Call Sign S2459), is granted. Accordingly, PanAmSat is authorized to operate the Intelsat 2 space station at the 169.1° E.L. orbital location in the 3700–4200 MHz (space-to-Earth), 5925–6425 MHz (Earth-to-space), 12250-12750 MHz (space-to-Earth), and 14000-14500 MHz (Earth-to-space) frequency bands, for an additional 28 months from its current end-of-term date of August 1, 2009, until December 1, 2011. Operations pursuant to this authorization shall be in accordance with the technical specifications set forth in the application, Federal Communication Commission rules, and are subject to the following conditions:

- 1) PanAmSat will operate the Intelsat 2 space station at the 169.1° E.L. orbital location subject to the previously established conditions for its operations at this orbital location. See IBFS File No. SAT-MOD-20080811-00153 (granted January 14, 2009).
- 2) PanAmSat is afforded thirty days from the release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute acceptance of this authorization as conditioned.
- 3) This authority is granted pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
