Spectrum Five LLC files this amendment to (1) shift the requested orbital location from 118.8 W.L. to 119.25 W.L. to provide a minimum .2 degree separation with DBS space stations; and (2) provide predicted transmitting off-axis antenna gain data for its proposed 17/24 GHz satellite.
