The application of ORBCOMM License Corp. (ORBCOMM), as amended, IBFS File Nos. SAT-MOD-20111021-00207 and SAT-AMD-20130212-00020, to modify its authorization for a non-voice, non-geostationary Mobile-Satellite Service (Little LEO) system IS GRANTED in part and DEFERRED in part, and the remaining requests in IBFS File No. SAT-AMD-20120809-00125 are DISMISSED as moot. Given ORBCOMM's successful launch of six next-generation satellites,¹ we partially grant its request to extend the fourth milestone in its *Next Generation License*.² Specifically, we extend the time by which ORBCOMM must complete construction of and launch the first two next-generation satellites until July 14, 2014. This action renders moot ORBCOMM's earlier requests for modification or waiver of the fourth milestone contained in IBFS File No. SAT-AMD-20120809-00125. The other requests in the amendment have either been granted³ or become moot.⁴ We defer action on ORBCOMM's remaining request to extend or waive the final milestone in its *Next Generation License*.⁵ This grant is without prejudice to any decision on that request.
