The application of Orbcomm License Corp. (Orbcomm) to modify its authorization for a non-voice, non-geostationary mobile satellite service (Little LEO) system, IBFS File Nos. SAT-MOD-20111021-00207, SAT-AMD-20120809-00125, and SAT-AMD-20130212-00020 IS GRANTED in part and DEFERRED in part. We grant authority for an additional feeder link, centered at 150.025 MHz, for use by all currently operating satellites in the Orbcomm system, and authority to construct and operate that feeder link on 17 additional Orbcomm Generation 2 satellites. We defer action on all other aspects of the pending modification application, as amended. This grant is without prejudice to action on remaining portions of the amended modification application, including Orbcomm's request to extend or waive milestones.

This grant is subject to the following conditions:

1. Orbcomm is afforded 30 days from the date of release of this grant to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
2. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
