The Boeing Company seeks to amend this application to substitute SOM1101, LLC as the party seeking the grant of a license from the Commission to launch and operate the proposed non-geostationary satellite orbit ('NGSO') satellite system operating in the 17.8-20.2 GHz band (space-to-Earth) and in the 27.6-30.0 GHz band (Earth-to-space).
