Dear Ms. Dortch:

On January 24 and 25, 2018, representatives from O3b Limited met separately with legal advisors to Chairman Pai and Commissioners O'Rielly, Carr, Clyburn, and Rosenworcel, as well as representatives from the International Bureau<sup>1</sup> to discuss the above-referenced proceedings.

O3b expressed concern that recent proposed amendments to existing non-geostationary ("NGSO") processing round applications, <sup>2</sup> and Petitions for Reconsideration of the Commission's NGSO Report and Order, <sup>3</sup> would introduce significant uncertainty in the current Ku-/Ka-band and V-band processing rounds, and referenced the significant resources expended to date on NGSO systems of applicants who submitted applications by the NGSO

processing round cut-off date. O3b noted that there is ample Commission precedent relevant to these recent applications, including policies to prevent speculation and warehousing by limiting the number of unbuilt NGSO licensed systems and pending NGSO applications, and provisions that specify the changes that can be made to a processing round application without disqualifying the application as amended from consideration as part of the processing round.

O3b expects to comment on, as appropriate, each of the proposed amendments and petitions for reconsideration.
