Dear Ms. Dortch:

Pursuant to Section 25.119(f) of the Commission's rules, 47 C.F.R. § 25.119(f), this letter serves to notify the Commission that on March 9, 2012, consistent with the relevant portion of the *Order* of the International Bureau in the above-captioned docket, DISH Network Corporation ("DISH") consummated its transaction to acquire control over New DBSD Satellite Services G.P., Debtor-in-Possession ("DBSD"). On the same day, Gamma Acquisition L.L.C. ("Gamma"), a wholly owned subsidiary of DISH, consummated its transaction to acquire substantially all of the assets of TerreStar Networks Inc., Debtor-in-Possession, and its subsidiary TerreStar Licensee Inc., Debtor-in-Possession (collectively "TerreStar"). The TerreStar assets acquired by Gamma include the FCC authorizations held by TerreStar.

Concurrently with this notification, DISH and Gamma are filing the required notices of consummation with the International Bureau's IBFS filing system with respect to the specific
