APPLICATION FOR PRO FORMA ASSIGNMENT OF LICENSES

Planet Labs Inc. ("Planet") hereby requests authority from the Federal Communications Commission ("Commission") for the *pro forma* assignment to Planet of the licenses held by Terra Bella Technologies Inc. ("Terra Bella").¹ Terra Bella is an indirect, wholly-owned subsidiary of Planet,² and accordingly, the assignment is *pro forma* in nature. Approval of the assignment will facilitate internal corporate restructuring.

Approval of the proposed pro forma assignment application "does not require a waiver of, or a declaratory ruling pertaining to, any applicable Commission rule."³ The parties certify that "the proposed . . . assignment is *pro forma*" and "together with all previous *pro forma* transactions, [the proposed assignment] would not result in a change in the actual controlling party."⁴ Accordingly, the pro forma assignment application for the earth station licenses should "be deemed granted one business day after filing."⁵

Draper Fisher Jurvetson ("DFJ") is a group of venture capital investment funds led by founders, Timothy Draper, John H.N. Fisher, and Steve Jurvetson (the "DFJ Founders"). Historically, DFJ investments have focused on early-stage companies. Some of the more notable DFJ investments include Baidu (Nasdaq: BIDU), Box (NYSE: BOX), Cylance, Nervana (Intel), Skype, SolarCity (Nasdaq: SCTY), SpaceX, Tesla Motors (Nasdaq: TSLA), Twilio (NYSE: TWLO), Twitter (NYSE: TWTR), Tumblr (Yahoo!), Unity, Yammer (Microsoft), and Zoox.

Six DFJ funds (the "DFJ Funds") are investors in Planet and collectively hold a 12.39% equity interest on a fully diluted basis (the "DFJ Equity Interest"), as follows:

- Draper Associates Riskmasters Fund II, LLC (California LLC) 0.45% equity interest in Planet on a fully diluted basis;
- Draper Associates Riskmasters Fund III, LLC (California LLC) 0.37% equity interest in Planet on a fully diluted basis; and
- Draper Fisher Jurvetson Fund X, L.P. (Cayman Island Limited Partnership) 10.20% equity interest in Planet on a fully diluted basis.
- DFJ Growth III, L.P. (Delaware LLC) 1.01% equity interest in Planet on a fully diluted basis; and
- DFJ Growth III Parallel Fund, LLC (Delaware LLC) 0.05% equity interest in Planet on a fully diluted basis.

All of the Founders and management (the "Managing Directors") of the DFJ Funds are U.S. citizens. DFJ Founders and Managing Directors can be reached at 2882 Sand Hill Road, Suite 150, Menlo Park, CA, 94025. No other individual or entity (that is not controlled by one or more of the DFJ Founders) has control of the DFJ Funds or should be treated as having a 10% or greater voting interest in the DFJ Funds.¹
