DESCRIPTION OF PROPOSED *PRO FORMA* ASSIGNMENT AND PUBLIC INTEREST STATEMENT

Pursuant to Section 25.119 of the Commission's rules, DIRECTV Enterprises, LLC ("DIRECTV") and DIRECTV Latin America, LLC ("DTVLA") hereby seek Federal Communications Commission ("Commission" or "FCC") consent to the non-substantial or *pro forma* assignment of the SKY-B1 space station authorization (call sign S2922) from DIRECTV to DTVLA.

DIRECTV and DTVLA certify that the proposed assignment is *pro forma* and that, together with all previous *pro forma* transactions, it would not result in a change in the actual controlling party.

I. DESCRIPTION OF THE PROPOSED *PRO FORMA* ASSIGNMENT

A. Description of Transaction — Response to Question 43

This transaction proposes the non-substantial or *pro forma* assignment of the SKY-B1 space station authorization (call sign S2922) from DIRECTV to DTVLA. Both DIRECTV and DTVLA are indirect wholly-owned subsidiaries of AT&T Inc. As such, this transaction will not change the ultimate ownership or control of the authorization. Accordingly, the assignment is *pro forma* in nature, *see* 47 C.F.R. § 63.24(d), and qualifies for grant one business day after filing, without prior public notice, *see* 47 C.F.R. § 25.119(i).

B. Ownership Structure of Assignee – Response to Questions 40 and A.20

DTVLA, a Delaware limited liability company, is a wholly owned subsidiary of Vrio Finco 1 LLC, a Delaware limited liability company, which is a wholly owned subsidiary of Vrio Holdco Inc., a Delaware limited liability company, which is a wholly owned subsidiary of Vrio Corp., a Delaware corporation, which is a wholly owned subsidiary of AT&T Inc., a Delaware corporation. AT&T Inc. is a publicly traded company, and there is no one person or group that owns 10% or more of the stock of AT&T Inc.

The primary business for DTVLA is satellite television. Vrio Finco 1 LLC, Vrio Holdco Inc., Vrio Corp., and AT&T Inc. are holding companies.
