Dear Mr. Moffat:

This is in response to your petition regarding your municipality's precluding you from installing a 7'6" satellite dish on your property. I am writing to inform you of the recent developments in federal satellite antenna regulation.

On February 8, 1996, Congress passed the Telecommunications Act of 1996. Section 207 of the Act authorizes the Commission to draft rules to protect individuals' right to receive television and satellite broadcast signals by means of over-the-air reception devices. On August 6, 1996, in accordance with Section 207, the Commission issued a Report and Order that preempts restrictions on the installation of a satellite dish one meter or less in size. A copy of this Report and Order is enclosed.

On March 11, 1996, the Commission issued a Report and Order dealing with satellite dishes that are larger than one meter in diameter. A copy of this Report and Order is enclosed as well. As it is presently written, the Order presumptively allows installation of dishes that are two meters or less in diameter "in any area where commercial or industrial uses are generally permitted by nonfederal land-use regulation." See Report and Order FCC 96078 at 16. This Order is currently under review. The Commission solicited comments on this Report and Order to assist in this process. Once the review of all comments is completed, we will release a revised rule.

I hope that this information has been of assistance. Please contact me if you should have any further difficulties.
