Dear Ms. Salas:

On July 28, 1997, TRW Inc. ("TRW") filed an Application for Review of the letter ruling of the Office of the General Counsel ("OGC") dated June 27, 1997, in which the OGC denied TRW's request for an investigation into alleged violations of the Commission's ex parte rules by Mobile Communications Holdings, Inc. ("MCHI") in connection with the above-referenced proceeding. At that time, TRW was authorized to operate a satellite system in the Mobile Satellite Service Above 1 GHz (the "MSS Above 1 GHz") in some of the same bands that MCHI had recently been authorized to use for its own MSS Above 1 GHz system. See Mobile Communications Holdings, Inc., 12 FCC Rcd 9663 (Int'l Bur., 1997). TRW has since relinquished its MSS Above 1 GHz authorization, and therefore will no longer pursue Commission review of the OGC's letter ruling. Accordingly, TRW hereby withdraws its Application for Review of that letter ruling.
