
Pursuant to my initial inquiry to William Caton, dated January 13, 1997, I am inquiring about the International Bureau review of the MCHI "Big Leo" license application. MCHI is a small business which will offer, through its Ellipso system, low cost, wireless telephony around the world, including rural areas. To date, of the three licenses granted, all have been awarded to giants in the industry, none of which have demonstrated technical superiority to MCHI's Ellipso system.

There are four primary reasons why it is vitally important that MCHI be awarded a license. MCHI has developed an outstanding partnership with Vula Communications of South Africa, which is owned by major black trade unions, business and civic groups. Additionally, the partnership will spur economic development for South Africa, by providing quality low-cost service. Further, it is critical that the Commission move expeditiously. The process of consideration of the license application has profound cost implications for under-served communities as well as important partners in emerging world economies.

Finally, the Commission was able to make an initial decision in favor of the three large firm applicants within three weeks of the close of the pleading cycle in January 1995. Two years later, and five weeks after the close of the current pleading cycle for the two remaining small firm applicants, the Commission has yet to respond. This raises troubling questions of fairness and equitable treatment towards small firm applicants.

Clearly, the merits of awarding the license favor MCHI. I encourage you to expedite your processing of this license application, and look forward to a speedy resolution to this matter. Thank you for your consideration and assistance.


