Dear Madame Secretary:

On July 29, 2002, we transmitted, on behalf of Iridium Satellite LLC ("ISLLC"), an executed Satellite Contract (the "Contract") between Boeing Satellite Systems, Inc. ("Boeing") and ISLLC. Stanley Wiggins of the FCC's Wireless Telecommunication Bureau has asked for clarification regarding the reference to a "Stipulation Re Entry of Relief from Stay" on page 29 of the Contract. The Contract states that ISLLC executed such a document, and that such a document was attached to the Contract. However, such a document was never provided by Boeing, never executed by ISLLC, and thus never made a part of the Contract.
