NOTICE OF WITHDRAWAL OF PETITION TO STAY PROCEEDINGS

On July 19, 2001, Northpoint Technology, Ltd., and Broadwave USA, Inc. (collectively, "Northpoint") requested that the Commission stay proceedings regarding the above-captioned application until such time as more complete data regarding the DIRECTV 4S satellite's operation was made available to the public. In particular, Northpoint requested that the complete application, including data regarding the precise strength and other characteristics of the planned signals (which was contained on a CD-ROM that DIRECTV submitted as part of its application), be made available for public inspection.

The International Bureau subsequently made a copy of the data available to Northpoint's counsel. Having now reviewed the complete application of DIRECTV, Northpoint has no further comments upon on the application. Accordingly, Northpoint hereby withdraws its pending petition to stay proceedings.


