Hughes Network Systems, LLC (“HNS”) is a wholly-owned subsidiary of Hughes Communications, Inc. (“HCI”), a Delaware Corporation. HCI, in turn, is a wholly-owned subsidiary of EchoStar Corporation (“EchoStar”), a publicly traded Nevada corporation. In his capacity as trustee, subject to certain restrictions, Mr. Gouger holds, and has the ability to exercise voting power over, shares representing 18.3% of the equity interests (assuming conversion of all shares of outstanding Class B Common Stock into Class A Common Stock) and 16.9% of the voting interests in EchoStar (assuming no conversion of Class B Common Stock).
