Re: Supplement to Application of Intelsat License LLC to Launch and Operate Intelsat 29e, a Replacement Satellite with New Frequencies, at 50.0° W.L., File No. SAT-LOA-20130722-00097 (Call Sign S2913)

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat"), by counsel and at the request of International Bureau staff, hereby clarifies and supplements its above-referenced pending application to launch and operate Intelsat 29e, a replacement satellite with new frequencies, at 50.0° W.L.

Intelsat clarifies that Intelsat 29e's operations in the FSS Planned Band frequencies will be coordinated under the Administration of Papua New Guinea's International Telecommunication Union ("ITU") filing NEW DAWN FSS-1. Intelsat requests that the United States state its non-objection to Papua New Guinea's bringing into use the ITU filing NEW DAWN FSS-1 by the Intelsat 29e satellite, in accordance with ITU Circular Letter CR/333 (May 2, 2012).

Intelsat clarifies that the beam pointing data contained in the document named "Coordinates of The Maximum Gain Point of The Gateway and User Beams" that was attached to the February 7, 2014 supplement is identical to the beam pointing data provided in Schedule S. Intelsat provides the attached table mapping the beam pointing data for U1 to U45 and GW1 to GW6 with the corresponding .gxt file name with the uplink or downlink and its associated beam polarization.

Intelsat also provides the .gxt files for the following beams: G5HD, SAVU, GRU, TAVU, CGHU, CGVU, G1HU, and G2HU.

Intelsat clarifies that the requested waiver of Section 25.114(d)(3) should be applied to all of the beams listed in the attached table. This waiver is required for the aforementioned beams because the .gxt beams provided were meant to be

representative and did not necessarily correspond to the beam bore-site coordinates listed in the Schedule S beam pointing table attached to Schedule S.
