On September 15, 2016, Jonathan Rosenblatt, General Counsel of Spire Global, Inc. ("Spire"), met with representatives of the FCC's International Bureau ("Bureau") regarding the above-referenced proceeding. The following people participated in the meeting on behalf of the Bureau: Jose Albuquerque, Satellite Division Chief; Karl Kensinger, Deputy Division Chief; Chip Fleming, Chief Engineer; Stephen Duall, Policy Branch Chief; Cindy Spiers, Policy Branch Attorney Advisor; and Merissa Velez, Policy Branch Attorney Advisor.

Spire stated it had effectively completed negotiations with ORBCOMM License Corp. and it would submit the executed agreement to the FCC soon.
