Dear Ms. Dortch:

BlackSky Global LLC ("BlackSky") hereby responds to the letter dated June 25, 2018 ("Letter") of Planet Labs Inc. ("Planet") with respect to the above-referenced application ("Application"). Planet requests that a condition be added to any grant of the Application requiring completion of coordination with Planet when operating in the same shared frequency bands in which Planet operates.

As Planet acknowledges, BlackSky already committed in its Application to coordinate with other operators in the shared frequency bands at issue.¹ Planet too has accepted its responsibility to coordinate, both in its Letter and in a prior application to the Commission.² BlackSky is already engaged with Planet and shares its confidence that, with both parties proceeding in good faith, coordination can be quickly achieved.

Under these circumstances, BlackSky sees no need for a special condition requiring it to coordinate with Planet. Nevertheless, should the Commission determine that a condition is necessary, BlackSky will accept such a condition on a grant.

As the Commission is aware, BlackSky is under a tight timetable to ship its Global-1 satellite on July 15, 2018, for a September launch. Accordingly, BlackSky respectfully requests that the Commission determine expeditiously whether an express condition on BlackSky's license is necessary and proceed to grant that license, with or without such condition, as the Commission so determines.
