The Tomorrow Companies Inc. ("Tomorrow.io"), in accordance with 47 CFR §25.165 and condition 20(a) of the grant to ICFS File No. SAT-MOD-20240618-00138 ("Grant"), hereby submits the attached rider to the surety bond on file with the grant-in-part to File Nos. SAT-LOA-20221201-00167 and SAT-AMD-20230406-00075.

On October 3, 2024, the Commission's Space Bureau granted Tomorrow.io's application to modify its authority to construct, deploy, and operate a non-geostationary orbit satellite system for weather monitoring. The modification increased the number of authorized satellites from 4 to 18, thereby increasing the milestone requirement under 47 CFR §25.165(b)(1). The attached rider is required to maintain the original surety bond on file.¹

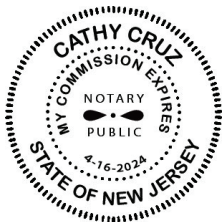
