WorldVu Satellites Limited (“OneWeb”), by counsel, files this letter pursuant to Section 1.65 of the Federal Communications Commission’s (“FCC”) rules¹ to provide updated ownership and contact information for the above-referenced pending petition requesting access to the U.S. market for OneWeb’s planned low earth orbit, non-geostationary orbit Ku- and Ka-band satellite system.
