Dear Ms. Dortch:

Iridium 2GHz LLC ("Iridium"), by its attorneys, hereby surrenders its authorization to launch and operate a 2 GHz satellite system, which the Federal Communications Commission ("Commission") granted on July 17, 2001. For business reasons, Iridium has decided no longer to pursue its plans for this satellite system.

Iridium also withdrew today, via the International Bureau's Filing System, its pending "Application for Modification and Public Interest Demonstration," which was filed August 28, 2003. Iridium's surrender of its 2 GHz authorization obviates the need for Commission action on this related application.
