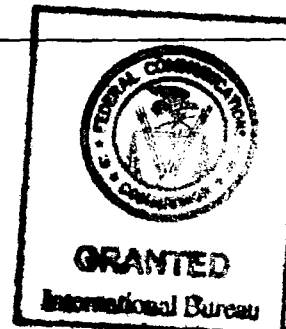

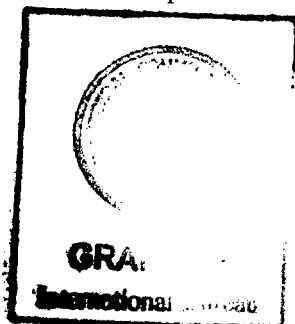

Intelsat LLC's request to modify its authorization, File No. SAT-MOD-20040503-00088, to relocate the INTELSAT 804 satellite from the 176.0° E.L. orbital location to the 174.0° E.L. orbital location and to operate the INTELSAT 804 satellite at the 174.0° E.L orbital location IS GRANTED in accordance with the terms, conditions, and technical specifications set forth in its application and this Attachment; and

1. During the drift of the INTELSAT 804 satellite from the 176.0° E.L. orbital location to the 174.0° E.L orbital location, Intelsat LLC shall not operate the communications payload on the satellite; and
2. Intelsat LLC shall coordinate its Tracking, Telemetry, Command, & Monitoring ("TTC&M") operations with all existing geostationary satellites to ensure that no unacceptable interference results from its TTC&M operations during its drift operations; and
3. During the drift, no harmful interference shall be caused by Intelsat 804 to any other lawfully operating in-orbit satellite, and operations of the Intelsat 804 satellite shall cease immediately upon notification of such interference; and
4. During the drift, Intelsat is required to accept interference from other lawfully operating in-orbit satellites; and
5. Intelsat LLC shall operate the INTELSAT 804 satellite at the 174.0° E.L orbital location in compliance with all existing coordination agreements; and
6. Intelsat LLC is afforded thirty days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned; and
7. This Grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
