Intelsat plans to start the relocation of INTELSAT 605 in October 2004 and have a satellite at the 178.0 degrees E.L. location in March/April 2005. At the new location, INTELSAT 605 will operate in inclined orbit. Intelsat is considering a possible temporary stop of INTELSAT 605 en route to 178.0 degrees E.L. In the event that Intelsat decides to do so, it will seek prior Commission authorization to stop the drift and operate the satellite at another location.
