Intelsat LLC hereby requests modification of the license for INTELSAT 602 to relocate the satellite from 50.5 E.L. to 150.5 E.L. As authorized by the FCC, Intelsat is currently drifting INTELSAT 602 to 157 E.L., and plans to stop it instead at 150.5 E.L. in June 2005. At the new location, INTELSAT 602 will operate in the inclined operation mode.
