Dear Ms. Dortch:

On December 8, 2008, Mobile Satellite Ventures Subsidiary LLC ("MSV Sub") changed its corporate name to SkyTerra Subsidiary LLC ("SkyTerra Sub").¹ MSV's Canadian joint venture partner, Mobile Satellite Ventures (Canada) Inc., which operates MSAT-1, also changed its name to SkyTerra (Canada) Inc.² The name changes are part of a coordinated effort to change the corporate names of all MSV-named entities operating in the United States and Canada to SkyTerra-named entities. Because the partners provide mobile satellite services on a seamless, North American-wide basis, this will facilitate a harmonized approach to the provisioning and branding of services on both sides of the border.
