The application of DIRECTV Enterprises, LLC (DIRECTV) to modify its authorization by relocating the DIRECTV 5 satellite (Call Sign S2673), a direct broadcast satellite, from its current location at 109.8° W.L. to 110.1° W.L., IBFS File No. SAT-MOD-20060717-00074, IS GRANTED. Accordingly, DIRECTV is authorized to relocate the DIRECTV 5 satellite from its current location at 109.8° W.L. to 110.1° W.L., an unoccupied location within the same orbital cluster, in accordance with the terms, conditions, and technical specifications set forth in its application, the Federal Communications Commission's (Commission) rules, and the conditions below.

1. DIRECTV must maintain the DIRECTV 5 satellite at 110.1° W.L. with $\pm 0.05^\circ$ longitudinal stationkeeping. See 47 C.F.R. § 25.210(j).
2. DIRECTV is afforded thirty days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
3. This Grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within thirty days of the date of the public notice indicating that this action was taken.
