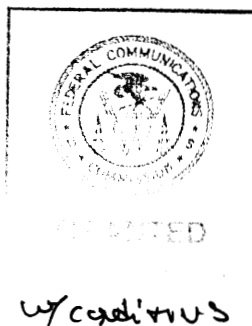

Conditions of Authorization
September 28, 2007

Loral Skynet Corporation's ("Loral") request, File No. SAT-MOD-20060821-00091, to modify its existing Ku/extended Ku-band satellite authorization (Call Sign S2357)¹ to change the orbital location to 37.55° W.L. from 37.5° W.L. and to operate with an increased transponder capacity and expanded geographical coverage IS GRANTED. Accordingly, Loral is authorized to construct, launch and operate its Ku/extended Ku-band satellite (Call Sign S2357) satellite at the 37.55° W.L orbital location in the 10.95-11.2 GHz, 11.45-11.7 GHz, 11.7-12.2 GHz, 12.5-12.75 GHz, 13.75-14.0 GHz, and 14.0-14.5 GHz frequency bands in accordance with the terms, conditions, and technical specifications set forth in its application, this Attachment and the Commission's Rules. Grant of this modification to change the orbital location of the satellite does not otherwise change the terms and conditions of Loral's existing authorization.

1. This action is without prejudice to any action on IBFS File No. SAT-MOD-20060306-00024.
2. Loral is afforded thirty days from the grant of this modification to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
3. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
