The application of TerreStar Licensee Inc. (TerreStar) to modify its 2 GHz Mobile-Satellite Service Spectrum Reservation, IBFS File No. SAT-MOD-20070529-00075, is GRANTED.¹ Accordingly, TerreStar's spectrum reservation for operation on selected service-link assignments in the 2000-2020 MHz and 2180-2200 MHz frequency bands to provide MSS in the United States via the TerreStar-1 (aka CANSAT-24) satellite IS MODIFIED to reflect that TerreStar-1 will operate at the 111.0° W.L. orbital location, and to update the technical parameters of those operations as specified in the above-referenced file.
