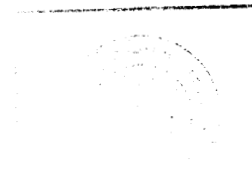

The request of DIRECTV Enterprises, LLC ("DIRECTV") for a modification of its authorization, File No. SAT-MOD-20070626-00087,¹ IS GRANTED. Accordingly, DIRECTV IS AUTHORIZED to operate its Fixed-Satellite Service (FSS) Ka-band space station, SPACEWAY 1, at the 102.885° W.L. orbital location in the 18.3–18.8/19.7–20.2 GHz (Downlink) and 28.35–28.60/29.25–30.00 GHz (Uplink) frequency bands. This authorization is granted in accordance with the terms, conditions, and technical specifications set forth in DIRECTV's application, this Attachment, and the Commission's rules:

1. DIRECTV must coordinate all of its Ka-band downlink operations with Federal fixed-satellite systems, both geostationary and non-geostationary, in accordance with footnote US334 to the Table of Frequency Allocations, 47 C.F.R. § 2.106. Absent a coordination agreement pursuant to footnote US334, DIRECTV shall operate its Ka-band downlinks on a non-harmful interference basis with regards to Federal systems in the 18.3–18.8 and 19.7–20.2 GHz bands and must terminate its Ka-band downlink operations immediately in the event that such operations cause harmful interference into operating Federal systems. In addition, DIRECTV must accept interference from such systems absent a coordination agreement pursuant to footnote US334.
2. DIRECTV must maintain the SPACEWAY 1 satellite at 102.885° W.L. with +/- 0.05 degree longitudinal stationkeeping. *See* 47 C.F.R. § 25.210(j).
3. Other than the change in orbital location of the SPACEWAY 1 satellite from 102.800° W.L. to 102.885° W.L., the conditions of DIRECTV's existing authorization for the satellite remain unchanged.²
4. DIRECTV's request for extension of Special Temporary Authority, File No. SAT-STA-20070927-00134, IS GRANTED to the extent necessary, subject to the terms and conditions specified in File No. SAT-STA-20070628-00089, and otherwise IS DISMISSED AS MOOT.
5. DIRECTV is afforded thirty days from the date of this action to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
