PanAmSat Licensee Crop. herein requests permanent authority to relocate Galaxy 11 to, and operate the satellite at, 32.80 E.L. in order to provide critical back-up C- and Ku-band capacity at the nominal 33.0 E.L. for Intelsat 802, which experienced an anomaly that has reduced available solar array power.
