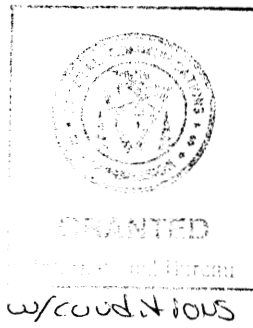

Mobile Satellite Ventures Subsidiary LLC (MSV's) application, IBFS File No. SAT-MOD-20080303-00055,<sup>1</sup> for modification of the space-station license for the Mobile Satellite Service (MSS) satellite, MSAT-2 (Call Sign: AMSC-1) IS GRANTED. Accordingly, MSV is authorized to operate MSAT-2 at the 101.3° W.L. orbital location with an East-West station-keeping range of  $\pm 0.05^\circ$ , using spectrum in the 1530-1544 MHz (space-to-earth), 1545-1559 MHz (space-to-earth), 1631.5-1645.5 MHz (Earth-to-space), and 1646.5-1660.5 MHz frequency bands for links with user terminals and using the 10.75-10.95 GHz (space-to-Earth), 13.0-13.15 GHz (Earth-to-space), and 13.2-13.25 GHz (Earth-to-space) frequency bands for feeder links, and using 11.7005 GHz, 11.701 GHz, 14.0005 GHz, and 14.4995 GHz for telemetry, tracking, and command signals, in accordance with the terms of the application, the previously authorized technical specifications for MSAT-2 for operational parameters other than orbital location,<sup>2</sup> and the Federal Communication Commission's rules.

This action is taken pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106 and 1.115, may be filed within 30 days of the date of the public notice announcing this action.
