TerreStar Networks Inc.'s (TerreStar's) application, IBFS File No. SAT-MOD-20080718-00143,<sup>1</sup> to modify its 2 GHz Mobile Satellite Service (MSS) Spectrum Reservation (Spectrum Reservation) IS GRANTED. Accordingly, TerreStar's Spectrum Reservation is modified to reflect an extension of its milestones to launch its satellite, TerreStar-1, at the 107.3°W.L. orbital location<sup>2</sup> from September 30, 2008 to June 30, 2009 and its final milestone requiring it to certify that its entire system is operational from November 30, 2008 to August 30, 2009.

1. Unless extended by the Commission for good cause shown, TerreStar must complete satellite construction and launch its satellite and certify that its entire system is operational in accordance with the modified milestone dates granted here and the technical parameters of its Spectrum Reservation. Failure to do so shall render the Spectrum Reservation null and void.

2. This action is without prejudice to any action on IBFS File Nos. SAT-MOD-20070529-00075, SES-LIC-20070530-00732, and SES-AMD-20071130-01642.

3. TerreStar is afforded 30 days from the date of this action to decline this Spectrum Reservation as conditioned. Failure to respond within this period will constitute a acceptance of the Spectrum Reservation as conditioned.

4. This action is taken on delegated authority pursuant to 47 C.F.R. § 0.261 and is effective immediately.
